Title: Resolution further amending and supplementing Resolution No. 180, effective April 5, 2000, entitled "Providing for an Agreement or Agreements, or use of existing Agreements and/or a Contract or Contracts, or use of existing Contracts, and for the purchase of materials, supplies, equipment, and/or services for various projects in connection with the Neighborhood Needs Program in Council District 3; and providing for the payment of the costs thereof," by reducing the line items Surveillance Cameras: 200 Block Moore Ave, Jucunda St. by \$15,000, and Upper Knoxville Blockwatch by \$1,000 and by adding the following Public Safety Initiative projects: 29th Ward Carrick Blockwatch \$4,000, 30th Ward Knoxville Blockwatch \$4,000, Upper Knoxville Blockwatch \$4,000 and Allentown Civic Association \$4,000. Total cost of all projects is not to exceed \$970,000.

Resolution further amending and supplementing Resolution No. 180, effective April 5, 2000, entitled "Providing for an Agreement or Agreements, or use of existing Agreements and/or a Contract or Contracts, or use of existing Contracts, and for the purchase of materials, supplies, equipment, and/or services for various projects in connection with the Neighborhood Needs Program in Council District 3; and providing for the payment of the costs thereof," by reducing the line items "Surveillance Cameras: 200 Block Moore Ave, Jucunda St." by \$15,000, and "Upper Knoxville Blockwatch" by \$1,000 and by adding the following Public Safety Initiative projects: 29th Ward Carrick Blockwatch \$4,000, 30th Ward Knoxville Blockwatch \$4,000, Upper Knoxville Blockwatch \$4,000 and Allentown Civic Association \$4,000. Total cost of all projects is not to exceed \$970,000.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution 180, effective April 5, 2000, as amended, which currently reads as follows:

The Mayor and/or the Deputy Mayor, and/or the Director of the Department of General Services, and/or the

Director of the Department of Engineering and Construction, and/or the Director of the Department of Public Works, and/or the Director of the Department of Parks and Recreation and/or the Director of the Department of City Planning are hereby authorized to enter into a contract or contracts, or use existing contracts, and/or Agreement or Agreements or use existing Agreements for various projects in connection with the Neighborhood Needs Program in Council District 3, in an amount not to exceed Nine Hundred Seventy Thousand Dollars (\$970,000.00), chargeable to and payable from the following chartfields:
