**Title:** Resolution amending Resolution No. 431 effective July 1, 2011 entitled: The Mayor and the Director of the Department of City Planning of the City of Pittsburgh are hereby authorized to enter into an Agreement or Agreements, in a form approved by the City Solicitor, with the following various community organizations, for operational/administrative expenses, maintenance, purchase of equipment and/or rehabilitation of neighborhood facilities for the benefit of residents of the City of Pittsburgh and further, authorizing various departments to enter into contract(s) or use existing contract(s) for street paving and other related costs, for the purchase of equipment and/or furniture and installation thereof, at a cost not to exceed \$1,000,000.00, so as to reprogram funds in City Council from the "Allegheny County Midget Football League" (- \$3,000.00); "Concrete Playgrounds" (- \$5,000.00); District 9 Equipment (-\$2,500.00) and Tomorrow's Future" (-\$2,000.00) and transfer these funds to "Poise Foundation - Hope Fund" (+\$12,500.00).

**Section 1.** Resolution No. 100, effective February 21, 2011, which presently read as follows:

Resolution providing for an Agreement or Agreements with various community organizations for operational/administrative expenses, maintenance, purchase of equipment and/or rehabilitation of neighborhood facilities for the benefit of residents of the City of Pittsburgh; and further, authorizing various City Departments to enter into contract or contracts or use existing contract or contracts for street paving, the purchase of equipment and/or furniture and other related costs at a cost not to exceed \$1,000,000.00.
