Section 1. Section 1 of Resolution No. 403, effective June 14, 2000, as amended, which currently reads as follows:

The Mayor and/or the Deputy Mayor, and/or the Director of the Department of General Services, and/or the Director of the Department of Engineering and Construction, and/or the Director of the Department of Public Works, and/or the Director of the Department of Parks and Recreation and/or the Director of the Department of

City Planning are hereby authorized to enter into a contract or contracts, or use existing contracts, and/or Agreement or Agreements or use existing Agreements for various projects in connection with the Neighborhood Needs Program in Council District 6, in an amount not to exceed Eight Hundred Eighty-One Thousand, Six Hundred Eighty-Two Dollars (\$881,682.00), chargeable to and payable from the following chartfields.
