Whereas, the Urban Redevelopment Authority of Pittsburgh has requested authorization to execute a Contract for Disposition by Sale of Land by and between the Urban Redevelopment Authority of Pittsburgh and Pittsburgh Housing Development Corporation, in connection with the sale of Block 27-B, Lot 166 in the 5th Ward of the City of Pittsburgh, for the sum of \$500.00 plus costs (estimated to total \$8,000.00);

Whereas the proposed Contract includes property located in the redevelopment area known as the Greater Hill District Redevelopment Area; and
