WHEREAS, pursuant to Ordinance 417, approved October 12, 1972, and in the manner prescribed by the Urban Redevelopment Law, Act of May 24, 1945, P.L. 991, as amended, the Neighborhood Housing Fund Cooperation Agreement was approved; and

WHEREAS, the Urban Redevelopment Authority of Pittsburgh has requested authorization to execute a Contract for Disposition by Sale of Land by and between the Urban Redevelopment Authority of Pittsburgh and the following redevelopers in connection with the sale of Block 61-C, Part of Lot 125, for \$9,900.00 plus costs, said property being located in the 19th Ward of the City of Pittsburgh:
