Resolution providing that the City of Pittsburgh enter into a Professional Services Agreement(s) and/or Contracts with Pittsburgh Event Childcare for professional services in connection with onsite childcare being provided to City of Pittsburgh employees during the days that school is not in session. Additionally, offsite childcare will be provided for those attending community events sponsored by the Mayor's Office of Neighborhood Services, and providing for payment of the cost thereof. Cost not to exceed \$45,000.00.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of Human Resources and Civil Service, on behalf of the City of Pittsburgh, are hereby authorized to enter into Professional Services Agreement(s) and/or Contracts with Pittsburgh Childcare Event, with an amount not-to-exceed Forty Five Thousand Dollars (\$45,000.00). The 2023 allocated money will be used for any remaining PPS Closures and future community meeting days. The 2024 allocated money will be used for PPS Closures and community meetings held throughout the year.

The City Controller shall encumber funds for the contract, subject to the amount of funds to be appropriated by City Council in respective budget year from the following chart account:

Section 2. Said agreement or agreements and any amendment or amendments shall be approved by the City Solicitor as to form and substance.
