Resolution amending Resolution No. 632 of 2017, authorizing the Mayor and Director of Public Safety to enter on behalf of the City of Pittsburgh into an amended agreement or agreements with Purvis Systems for installation of a new fire station alerting system and related support services. ## Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of Public Safety to enter on behalf of the City of Pittsburgh into an <u>amended</u> agreement or agreements with Purvis Systems for installation of a new fire station alerting system and related support services at an overall cost not to exceed <del>TWO MILLION TWO HUNDRED NINETY-SEVEN THOUSAND ONE HUNDRED and TWENTY-FOUR DOLLARS and FIFTY-ONE CENTS <u>TWO MILLION SEVEN HUNDRED SIXTY-THREE THOUSAND EIGHT HUNDRED TWENTY SEVEN DOLLARS and FIFTY-ONE CENTS</u> (\$2,297,124.512,763,827.51).</del>
