An Ordinance amending the Pittsburgh Zoning Code, Title Nine, Zoning, Article 1, Chapter 902, Section 902.03, Zoning District Maps numbered 6 and 11 by changing various zoning district classifications in the Troy Hill community in accord with the Pittsburgh Neighborhood Remapping Project relative to the City's new Urban Zoning Code.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** Section 902.03, Zoning District Maps numbered 6 and 11, of the Pittsburgh Code is hereby amended so as to change the following zoning district classifications:
