Resolution 260 of 2021 is amended as follows:

Section 1. The Mayor and the City Solicitor are hereby authorized to enter into a Professional Services Agreement with Campbell Durrant, P.C., for professional legal services and expert advice regarding labor matters at a cost not to exceed ~~Three Hundred Ninety Thousand Dollars and No Cents (\$390,000.00)~~, **Four Hundred Ninety Thousand Dollars and No Cents (\$490,000.00)**, chargeable to and payable from the following JD Edwards Accounts:
