Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution No. 428 of 2021, entitled "Resolution amending Resolution 475 of 2020 which provided for a professional services agreement or agreements with NCR Corporation, to provide city-wide credit, debit, and e-check payment services for the collection of various program and permitting fees for the City of Pittsburgh by exercising the option to extend the term of the Agreement for one year at no additional cost and updating the name of the vendor.," is hereby amended as follows:

Section 1. The Mayor, the Director of the Department of Finance, and the Director of Innovation & Performance, on behalf of the City of Pittsburgh, are hereby authorized to enter into a professional services agreement or agreements or amendments, in a form approved by the City Solicitor, with NCR Corporation to city-wide credit, debit, and e-check payment services for the collection of various program and permitting fees for the City of Pittsburgh, extending the term of the agreement an additional [year] **three years** through [2022] **2027** at no additional cost past the original not to exceed Thirty Thousand Dollars (\$30,000), chargeable to and
