Resolution providing for a Contract or Contracts, or the use of existing Contracts for street resurfacing programs to include, but not limited to, hot mix asphalt, crack sealing, equipment purchases, sawing and sealing, asphalt milling, truck rental, brick and blockstone repairs, handicap ramps, salaries for city crews, concrete slab replacement and parks related asphalt work at various locations throughout the City of Pittsburgh, and providing for the payment of (\$3,600,000) Dollars the cost thereof.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Director of the Department of General Services and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to advertise for proposals and to award and enter into a Contract or Contracts, or the use of existing Contracts in a form approved by City Solicitor, for street resurfacing programs to include but not limited, hot mix asphalt, crack sealing, equipment purchases, sawing and sealing, asphalt milling, truck rental, brick and blockstone repairs, transfers to salary accounts for city crew salaries, handicap ramps, concrete slab replacement and parks related asphalt work at various locations throughout the City of Pittsburgh, at a cost not to exceed Three Million Six Hundred Thousand (\$3,600,000) Dollars, chargeable to and payable from Fund 5100, Org. 400000, Sub-Class PGHPR, Project 2239000, Budget Year 2003, Account 525500, Citywide Resurfacing, Department of Public Works.
