Resolution amending Resolution 336 of 2019 entitled “A Resolution providing for a Contract or Contracts, or the use of existing Contracts, an Agreement or Agreements, or the use of existing Agreement, providing for the planning, design, repairs, maintenance, improvements, emergencies, operations, and / or the purchase of materials, equipment, and supplies in connection with the production of the Hill District Mobility Network and Parking Management Plan and associated projects;” to provide for a specific payee and authorize entering into a contract for the Hill District Transportation Study.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.**

Section 1 of Resolution 336 of 2019 shall be amended as follows:

The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, **having advertised and received proposals** are hereby authorized [to advertise for proposals and to award and] to enter into a Contract or Contracts **with Kittelson & Associates, Inc.**, [or to use existing Contracts, an Agreement or Agreements, or to use existing Agreements, providing for the planning, design, repairs, maintenance, improvements, emergencies, operations, and / or the purchase of materials, equipment,

and supplies] in connection with the production of the Hill District Mobility Network and Parking Management Plan and associated projects. The project is at a cost not to exceed \$199,947.00 chargeable and payable from the following account: 6074011019.50000.00
