**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and/or the Deputy Mayor, and/or the Director of the Department of General Services, and/or the Director of the Department of Engineering and Construction, and/or the Director of the Department of Public Works, and/or the Director of the Department of Parks and Recreation, and/or the Director of the Department of City Planning and/or the City Clerk are hereby authorized and directed to enter into a contract or contracts, or use existing contracts, and/or Agreement or Agreements or use existing Agreements for various projects in connection with City Council's 2001 Neighborhood Needs Supplement Program in an amount not to exceed Eight Hundred Ninety-Seven Thousand Seven Hundred Seventy-One Dollars and Twenty-Six Cents (\$897,771.26) ~~Nine Hundred Fifty-Eight Thousand Four Hundred Eighty-Seven Dollars and Twenty-Six Cents (\$958,487.26)~~ chargeable to and payable from the following chart-fields.
