**WHEREAS**, established in 1917, The Brashear Association has consistently demonstrated an ability to respond to the changing and diverse needs of South Pittsburgh's multicultural, multigenerational community; and,

**WHEREAS**, Brashear's solid reputation of providing service excellence for more than 100 years has made it a sought-after partner among others who are working toward solutions to community challenges; and,

**WHEREAS**, Brashear regularly shares its experience and expertise, along with its centrally located facilities, in support of a number of community initiatives, such as LifeSpan, and the Birmingham Foundation; and,

**WHEREAS**, LifeSpan operates two service programs to support the homebound residents of Allegheny County. Their Options Care Management program has assisted 2,451 residents to remain safe and healthy in their homes through the development, implementation and monitoring of a comprehensive care assistance plan. Their Meals on Wheels Program has delivered in excess of 168,400 hot, cold and frozen meals annually to the homes of the frail, homebound residents. ; and,
