Resolution authorizing the Mayor and the Director of the Office of Management and Budget to enter into a Grant Agreement with Allegheny County for the purpose of receiving Coronavirus Relief funds in the amount of Six Million Two Hundred Thousand (\$6,200,000.00), which shall be used to reimburse eligible City expenditures.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Office of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Grant Agreement with Allegheny County for the receipt of Coronavirus Relief funds in the amount of Six Million Two Hundred Thousand (\$6,200,000.00). These grant funds shall be used to reimburse eligible City expenditures related to the COVID-19 response, as set by County and federal guidelines. The grant agreement shall be approved as to form and substance by the City Solicitor and monies shall be deposited into the Grants Trust Fund account 0229400326.45703.00.

Section 2. The Mayor and the Director of the Office of Management and Budget are further authorized to make all legitimate reimbursements under the terms and conditions of the Grant Agreement with Allegheny County as outlined in Section 1 of this resolution. Said reimbursements shall not exceed Six Million Two Hundred Thousand (\$6,200,000.00) and shall be transferred from the Grants Trust Fund account 0229400326.58101.00 to the appropriate general fund or trust fund accounts.
