Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor, on behalf of the City of Pittsburgh, is hereby authorized to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, under which the Urban Redevelopment Authority of Pittsburgh will undertake the certain programs and projects, ~~providing the waiver of permit fees for contractors retained by URA in the construction of any public improvements,~~ **and providing for** the payment to URA of an administrative fee of 10% of the amount transferred and providing for the transfer to URA of an amount not to exceed One Million Three Hundred Twenty-five Thousand (\$1,325,000) Dollars, chargeable to and payable from the following accounts:
