Resolution providing for the execution of a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh for the administration of certain projects and programs, and providing for the payment of the cost thereof, not to exceed \$1,325,000. (Council Districts: All).

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor, on behalf of the City of Pittsburgh, is hereby authorized to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, under which the Urban Redevelopment Authority of Pittsburgh will undertake the certain programs and projects, providing the waiver of permit fees for contractors retained by URA in the construction of any public improvements, and providing for the payment to URA of an administrative fee of 10% of the amount transferred and providing for the transfer to URA of an amount not to exceed One Million Three Hundred Twenty-five Thousand (\$1,325,000) Dollars, chargeable to and payable from the following accounts:
