Resolution amending Resolution No. 370, effective July 11, 2008 entitled "Resolution providing that the City enter into a temporary professional services agreement for the purpose of providing an excess workers' compensation insurance policy, cost not to exceed \$357,488.00" so as to increase the amount by \$33,405.00 from \$357,488 to \$390,893.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1**. Amending Resolution No. 370, effective July 11, 2008, entitled "Resolution providing that the City enter into a temporary professional services agreement for the purpose of providing an excess workers' compensation insurance policy, cost not to exceed \$357,488.00" by increasing the amount by Thirty Three Thousand, Four Hundred and Five Dollars (\$33,405) from Three Hundred Fifty Seven Thousand, Four Hundred Eighty Eight Dollars (\$357,488) to Three Hundred Ninety Thousand, Eight Hundred Ninety-Three Dollars (\$390,893). This amount shall be chargeable to and payable from Account 574600, Fund 8170, Organization 999300, SubClass 600, and Budget Year 2008, Department of Personnel and Civil Service.

**Section 2.** The City Controller shall encumber funds for the annual contract, subject to the amount of funds to be appropriated by City Council from the following chart accounts:
