**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements, or to use existing Agreements, to enter into a Contract or Contracts, or to use existing Contracts, and to purchase materials and supplies, in connection with the Reconstruction of Forbes Avenue, Wood Street to Smithfield Street; including Construction Management Services, and providing for a Reimbursement Agreement with the Commonwealth of Pennsylvania, Department of Transportation; at a cost not to exceed \$104,666.00, chargeable to and payable from the following accounts:
