**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** Resolution No. 704, effective January 1, 2008, entitled: "Adopting and approving the 2008 Capital Budget and the 2008 Community Development Block Grant Program; and approving the 2008 through 2012 Capital Improvement Program," is hereby amended and supplemented by increasing the amount of CDBG funds from \$16,000,000 to \$16,490,923 to reflect the final approved grant amount from the U.S. Department of Housing and Urban Development.
