Amount not to exceed Sixteen Thousand Five Hundred and Fifty Dollars (\$16,550).

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and/or the Director of the Department of Public Works, and/or the Director of General Services, on behalf of the the City of Pittsburgh, are hereby authorized to advertise for proposals and to award and enter into an Agreement or Agreements, or the use of existing Agreements in a form approved by City Solicitor, for completion of a community building at the corner of Second and Johnston Avenues in Hazelwood. The original construction costs were provided from District 5 Neighborhood Needs funds. The Mayor's funds will pay for the interior and exterior finish and some landscaping work. Amount not to exceed Sixteen Thousand Five Hundred and Fifty Dollars (\$16,550.00) chargeable to and payable from Mayor's Office - Hazelwood Beautification Project # 2267057, Account 600000, Fund 2610, Org. 102000, Sub-Class C2001, Budget Year 2001.
