Resolution amending Resolution No. 459, effective August 2, 2006, entitled "Providing for the execution of a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh for the performance of certain work in connection with the 2006-2007 Community Development Block Grant Program, and providing for the payment of the cost thereof, not to exceed \$7,278,345" by reducing the Neighborhood Business and Economic Development line item by \$700,000 and transferring the funds to Neighborhood Housing Initiative. ## Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution No. 459, effective August 2, 2006, which currently reads:

"Section 1.
