Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Pittsburgh Code, Title Four, Public Places and Property; Article VII, City Realty; Chapter 452, Acquisition of City Property, Section 452.01, "Advertisement of City Property" is hereby supplemented by adding paragraph (j) which reads as follows:

## 452.01 ADVERTISEMENT OF CITY PROPERTY.

(j) The Director of Finance is authorized to enter into agreements with participating members of the Realtors Association of Metropolitan Pittsburgh to market selected City-owned properties in accordance with the provisions of Section 452.02 of this Chapter
