Resolution amending Resolution 248 of 2023, which authorized the Mayor and the Director of the Department of Public Safety to enter into an Agreement or Agreements with the Pittsburgh Downtown Partnership to provide an ambassador program to assist police with non-criminal matters in the Central Business District, by increasing the approved amount by \$600,000 for an amended total cost not to exceed ONE MILLION TWO HUNDRED THOUSAND DOLLARS (\$1,200,000) over two years.

Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution 248 of 2023, authorizing the City of Pittsburgh to enter into an Agreement or Agreements with the Pittsburgh Downtown Partnership, is hereby amended as follows:

Section 1. The Mayor and the Director of Public Safety, on behalf of the City of Pittsburgh, are hereby authorized to enter into an **Amended** Agreement or Agreements with the Pittsburgh Downtown Partnership to provide an ambassador program to assist police with non-criminal matters in the Central Business District, at an overall cost to the City not to exceed ~~SIX HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$600,000.00)~~ **ONE MILLION TWO HUNDRED THOUSAND DOLLARS (\$1,200,000.00) over two years.**

Section 2. The City Controller shall encumber funds for said **Amended** Agreement(s), subject to

appropriations by City Council in respective budget years, from the following chart of accounts:
