Resolution authorizing a Cooperation Agreement between the City of Pittsburgh (“City”) and the Pittsburgh Water and Sewer Authority (“PWSA”) to implement a revised governance structure for the Pittsburgh Water and Sewer Authority **and further authorizing an amendment to the 1995 Capital Lease Agreement to terminate PWSA’s option to purchase the leased property in 2025.**  
(Public Hearing held 7/18/18)

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor, on behalf of the City of Pittsburgh, is hereby authorized to enter into a Cooperation Agreement with the Pittsburgh Water and Sewer Authority (“PWSA”) to implement a revised governance structure for PWSA, **which contemplates a separately enacted ordinance** establishing a City Board of Nominators to nominate potential candidates to serve on the Board of Directors **of the PWSA, subject to requirements of applicable law.**

**Section 2. The Cooperation Agreement will also amend the 1995 Capital Lease Agreement to terminate PWSA’s option to purchase the leased property in 2025.**

Section 3. Said Cooperation Agreement shall be in a form approved **by the City Solicitor** and shall, in addition to the terms and conditions specified herein, contain other terms and conditions that may be in the interest of the City.

Section 4. The **proposed** Cooperation Agreement is attached hereto **as Exhibit A.**

Section 5. Any revisions to the terms and conditions of the attached **proposed** Cooperation Agreement shall be resubmitted to City Council for its consideration. **Once the Cooperation Agreement is negotiated by the City and PWSA, it shall not be finally executed until approved by a majority vote of City Council pursuant to an amendment to this resolution.**

Section 6. Any future revisions to the Cooperation Agreement must be approved by a majority vote of City Council **pursuant to an amendment to this resolution.**
