## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of City Planning, on behalf of the City of Pittsburgh, are hereby authorized and directed to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, under which the Urban Redevelopment Authority of Pittsburgh will undertake the following programs and activities in connection with the 2002 Community Development Block Grant Program at a cost not to exceed One Million Three Hundred Twenty-Five Thousand (\$1,325,000) Dollars, chargeable to and payable from the 2002 Community Development Block Grant Trust Fund as follows:
