Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution authorizing The Mayor and the City Solicitor, <u>on behalf of the City of Pittsburgh</u>, are authorized to enter into a professional services agreement with Loeb & Loeb LLP at an amount not to exceed One Hundred and Fifty Thousand Dollars (\$150,000.00) Four Hundred Thousand Dollars (\$400,000.00), over one year, for legal services related to real estate matters, chargeable to and payable from 11101.108000.53.53517.2023.

Section 2. Said Agreement or Agreements or amendments thereto are to be approved by the City Solicitor as to form.
