## The Council of the City of Pittsburgh hereby enacts as follows:

**Section 1.** That the name of WOODRING COURT, along its entire length beginning at its intersection with Suismon St at its southeasterly end to its northwesterly terminus, shall be and the same is hereby approved, located in the Twenty-Third Ward.
