Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements or to use existing Agreements, in form approved by the City Solicitor, with a Consultant or Consultants, for Project Management Services, to assist the City in the implementation of our Federal and State funded projects, at a cost not to exceed \$250,000.00, chargeable to and payable from the following account:
