Title: Resolution amending Resolution No. 317 of 2021, authorizing the Mayor and Director of Public Safety to enter on behalf of the City of Pittsburgh into an amended agreement or agreements with Purvis Systems for installation of a new fire station alerting system and related support services by increasing the approved amount by \$634,700.00 for an amended total cost not-to-exceed THREE MILLION THREE HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED TWENTY-SEVEN DOLLARS AND FIFTY-ONE CENTS (\$3,398,527.51) over ten years.

Resolution amending Resolution No. 317 of 2021, authorizing the Mayor and Director of Public Safety to enter on behalf of the City of Pittsburgh into an amended agreement or agreements with Purvis Systems for installation of a new fire station alerting system and related support services by increasing the approved amount by \$634,700.00 for an amended total cost not-to-exceed THREE MILLION THREE HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED TWENTY-SEVEN DOLLARS AND FIFTY-ONE CENTS (\$3,398,527.51) over ten years.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of Public Safety to enter on behalf of the City of Pittsburgh into an amended agreement or agreements with Purvis Systems for installation of a new fire station alerting system and related support services at an overall cost not to exceed ~~TWO MILLION SEVEN HUNDRED SIXTY-THREE THOUSAND EIGHT HUNDRED TWENTY-SEVEN DOLLARS and FIFTY-ONE CENTS (\$2,763,827.51)~~ **THREE MILLION THREE HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED TWENTY-SEVEN DOLLARS AND FIFTY-ONE CENTS (\$3,398,527.51).**

Section 2. The City Controller shall encumber funds for said amended agreement or agreements from the following accounts in their respective budget years with corresponding dollar amounts as follows, subject to annual appropriation by City Council for future years:
