Resolution amending Resolution 350 of 2020 to authorize the entering into of leases by the Department of City Planning for display of art in connection with a Professional Services Agreement with BOOM Concepts and/or Bloomfield-Garfield Corporation.

WHEREAS, the City of Pittsburgh recently entered into an agreement with BOOM Concept for presentation of social justice-oriented artwork in City-owned spaces; and

WHEREAS, the City of Pittsburgh wishes to expand the scope of this program to include City-leased spaces in addition to City-owned spaces.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution 350 of 2020 shall be amended as follows:

Section 1. Authorizing the Mayor and the Department of City Planning to enter into a Professional Services Agreement with BOOM Concepts and/or Bloomfield-Garfield Corporation to coordinate a program of responsive temporary art by local artists for temporary display on City-owned <u>or City-leased</u> structures in the public realm, at a cost not to exceed Five Thousand Dollars (\$5,000.00), and payable from the Office of Equity and JDE Account 11101.102100.53.53901.2020.

Section 2. The form and substance of this Agreement shall be approved by the City Solicitor.

Section 3. <u>The Director of the Department of City Planning, on behalf of the City of Pittsburgh, shall</u> be authorized to enter into leases for display of art as provided in the Professional Services Agreement authorized in Section 1 herein.
