WHEREAS, Victorious Faith Evangelistic Outreach (VFEO) was founded by *Pastor Charles and Dr. Shirley Brown* and LaVerne Haines-Stevens in June of 1986 as an interdenominational outreach ministry which was first located in the Clark Building downtown and are now celebrating their 25th Anniversary and a mortgage burning for their church; and,
