**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** Pursuant to Chapter 218 of the City Code, regarding capital projects that have been inactive for at least three years, Resolution No. 855 of 2011, effective January 1, 2012, as amended, which presently reads as per **Current Budget Amount**, is hereby amended to read as per **Revised Budget Amount**.
