Resolution authorizing the Mayor and the Director of the Department of Public Safety, on behalf of the City of Pittsburgh, to enter into a professional services agreement with Zambelli Fireworks Manufacturing Co., for the display of a fireworks show in conjunction with the City of Pittsburgh’s Independence Day Festival at an amount not to exceed SIXTY-SEVEN THOUSAND THREE HUNDRED SEVENTY-FIVE DOLLARS (\$67,375).

WHEREAS, the City of Pittsburgh requires as part of its Independence Day Festival, professional services for a fireworks display; and

WHEREAS, Zambelli Fireworks Manufacturing Co., was selected through a competitive process as qualified for the performance of said professional services; and

WHEREAS, the City of Pittsburgh now wishes to enter into an agreement with Zambelli Fireworks Manufacturing Co., for the performance of a fireworks display in conjunction with the City of Pittsburgh’s Independence Day Festival.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Department of Public Safety, on behalf of the City of

Pittsburgh, are authorized to enter into a professional services agreement with Zambelli Fireworks Manufacturing Co., for the display of a fireworks show in conjunction with the City of Pittsburgh's Independence Day Festival at an amount not to exceed SIXTY-SEVEN THOUSAND THREE HUNDRED SEVENTY-FIVE DOLLARS (\$67,375) authorized and appropriated from the following code account: 5000731400.53901.00.

**Section 2.** Said agreement shall be approved by the City Solicitor as to form and substance.
