Resolution providing that the City of Pittsburgh enter into a renewal of the professional services Contract or Contracts currently in place for the purposes of on-going medical care provided to City of Pittsburgh employees who require treatment for service related injuries and/or illnesses pursuant to the Pennsylvania Workers' Compensation Act and providing for the payment of the cost thereof, not to exceed \$5,512,499.00 plus administrative costs not to exceed \$481,909.00.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of Personnel and Civil Service Commission, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Contract or Contracts, in a form approved by the City Solicitor: ALLEGHENY GENERAL HOSPITAL (AGH) shall provide on-going treatment for service related injuries and/or illnesses to CITY employees under the Pennsylvania Workers' Compensation Act. AGH shall render comprehensive medical care services for CITY employees on an as-needed basis, provide inpatient as well as ambulatory services for injured CITY employees, provide case management and claims management services and provide infectious disease management and pharmacy review services as described in the original contract dated January 1, 2002. AGH shall maintain application outsourcing services and hosting services for the performed of medical care and services as agreed upon in the contract made between the City of Pittsburgh and Allegheny General Hospital on June 13, 2002 at a cost not to exceed
