Resolution providing for the designation as a Historic Structure under Section 513 of Chapter 1007 of the Code of Ordinances that certain structure known as the Panther Hollow, spanning Panther Hollow in Schenley Park, in the 14<sup>th</sup> Ward, City of Pittsburgh.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** Whereas, the City of Pittsburgh has duly enacted Section 513 of Chapter 1007 of the Code of Ordinances, which protects and preserves Historic Structures, Districts, Sites, and Structures; and

Whereas, Mr. Walter Kidney, a resident of Pittsburgh, has nominated the Panther Hollow Bridge for designation as a Historic Structure; and

Whereas, the Historic Review Commission has held a public hearing to gather testimony from property owners and other interested parties concerning the appropriateness of this designation; and

Whereas, the Historic Review Commission has voted to recommend that City Council designate the Panther

Hollow Bridge as a Historic Structure; and

Whereas, the City Planning Commission has held a public hearing to gather testimony from property owners and other interested parties concerning the appropriateness of this designation; and

Whereas, the City Planning Commission has voted to recommend that City Council designate the Panther Hollow Bridge as a Historic Structure; and

Whereas, the Council of the City of Pittsburgh has held a public hearing to gather testimony from the public concerning the appropriateness of this designation; and

Whereas, the Council of the City of Pittsburgh finds that the aforementioned Structure is a Historic Structure that should be preserved;

Pursuant to the provisions of Section 513.3 of Chapter 1007 of the Code of Ordinances, the Council of the City of Pittsburgh hereby designates as a Historic Structure the structure known as the Panther Hollow Bridge, spanning Panther Hollow in Schenley Park, in the 14<sup>th</sup> Ward, City of Pittsburgh.
