Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. That Resolution No. 310 effective, May 8, 2003, which presently reads,

"The Mayor and the Director of the Department of City Planning, on behalf of the City of Pittsburgh, is hereby authorized to enter into an Agreement or Agreements, or Contract or Contracts, or use of existing Agreement(s) or Contract(s) with consultants, vendors and/or contractors for the purpose of planning and/or implementation cost of the Trail Development Project and related costs in support of this project, at a cost not to exceed \$330,000, \$280,000, chargeable to and payable from 2003 "Department of City Planning", Trail & Bike Route Development Program: 500000-5100-110000-PGHPR-2205904-2003; and \$50,000, chargeable to and payable from 2003 "Department of City Planning - Trail - Bike Route Development Program": 500000-2610-110000-

C2003-2205904-2003."
