Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1 of Resolution No. 134 of 2017 effective March 20, 2017, which presently reads as follows:

Section 1. The Mayor and the Director of the Department of the Office of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Professional Services Agreement(s) and/or Contract(s) with Malady & Wooten, Inc. for professional consulting services for state government affairs and legislative services, and providing for the payment thereof, at a cost not to exceed \$66,000.00 (\$5,500.00 monthly retainer), chargeable to and payable from the following JD Edwards Account: 11101.53.53101.102200.2017, Item Number 1158.
