The Mayor and the Director of the Commission on Human Relations, on behalf of the City of Pittsburgh, are hereby authorized to enter into an amended Agreement(s) with Keen360, Inc. to provide ongoing technical support, development and maintenance to the Commission for its customer service portal by increasing the approved amount by Five Thousand, Nine Hundred Twenty-Four Dollars and Ninety-Seven Cents (\$5,924.97) for an amended total cost not-to-exceed Fifty-Nine Thousand, Eight Hundred Sixty-Five Dollars and Seventy-Two Cents (\$59,865.72) over Five (5) years chargeable to and payable from the following accounts:
