Amending Resolution No. 510, effective August 17, 2009, entitled "Authorizing the Urban Redevelopment Authority of Pittsburgh to submit an Application to the Pennsylvania Office of the Budget for a Redevelopment Assistance Capital Program grant of up to \$1,400,000 for the Pittsburgh Symphony project by increasing the amount of the grant to \$2,150,000 \$2,400,000. (The State has allocated an additional \$250,000 for this project, bringing the total to \$2,400,000) (Council District 6)

Whereas, by Resolution No. 510, effective August 17, 2009, the Council of the City of Pittsburgh authorized Urban Redevelopment Authority of Pittsburgh ("URA") to submit an application to the Commonwealth of Pennsylvania Office of the Budget (the "Commonwealth") for a grant under the Redevelopment Assistance Capital Program ("RACP") in the amount of \$1,400,000 for the Pittsburgh Symphony project (the "Project"); and

Whereas, the Commonwealth has increased the grant to \$2,150,000 \$2,400,000, which requires an amendment to Resolution No. 510 to reflect the increased grant;

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution No. 510, effective August 17, 2009, which currently reads as follows:
