Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Innovation & Performance, on behalf of the City of Pittsburgh, are authorized to enter into an agreement or agreements with CIS (Center for Internet Security) for a one-year term for Albert MD Monitoring application which predicts malicious activity on the City network by monitoring, alerting and analyzing information gathered by sensors at a one-time cost not to exceed \$14,700 (Fourteen Thousand Seven Hundred Dollars and Zero Cents) The agreement or agreements may include a provision to authorize an amendment or amendments to extend the term for up to three (3) additional option years (2021, 2022, 2023) subject to annual appropriation of City Council
