Resolution amending Resolution 642 of 2019, a resolution authorizing the Mayor and the Director of the Department of Innovation & Performance to enter into an Agreement or Agreements with Computronix (USA) Inc., for the provision of a permitting and licensing package, at an additional cost not to exceed Two Hundred and Fifty Five Thousand Dollars and Zero Cents (\$255,000.00).

Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution amending Resolution 642-2019 entitled "Resolution amending Resolution 158 of 2017, a resolution authorizing the Mayor and the Director of the Department of Innovation & Performance to enter into an Agreement or Agreements with Computronix (USA) Inc., for the provision of a permitting and licensing package, at an additional cost not to exceed One Million Four Hundred Eighty Thousand and Zero Dollars (\$1.480,000.00) over the next two years" is hereby amended as follows:

Section 1. The Mayor and the Director of the Department of Innovation & Performance, on behalf of the City of Pittsburgh are hereby authorized to enter into an Agreement or Agreements or Amendments with Computronix (USA) Inc. for the provision of a permitting and licensing package at a cost not to exceed [Six Million Six Hundred Nineteen Thousand Four Hundred Two Dollars (\$6,619,402.00)] Six Million Eight Hundred Seventy Four Thousand Four Hundred and Two Dollars (\$6,874,402) over five years, subject to annual appropriation by City Council for future years. This cost includes implementation, training, maintenance, professional services, annual software subscriptions, and production support services and
