Resolution amending Resolution 77, effective date February 25, 2003, entitled: Providing for a Contract or Contracts or the use of existing Contracts for street resurfacing programs to include, but not limited to, hot mix asphalt, crack sealing, equipment purchases by increasing the total from One Million Four Hundred Thousand Dollars (\$1,400,000.00), to Three Million Nine Hundred Forty Four thousand Nine Hundred Eighty Eight Dollars (\$3,944,988.00).

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Res. 77-03, effective February 25, 2003, which presently reads as:

The Director of the Department of General Services and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to advertise for proposals and to award and enter into a Contract or Contracts, or the use of existing Contracts in a form approved by City Solicitor, for street resurfacing programs to include but not limited, hot mix asphalt, crack sealing, equipment purchases, sawing and sealing, asphalt milling, truck rental, brick and blockstone repairs, transfers to salary accounts for city crew salaries, handicap ramps, concrete slab replacement and parks related asphalt work in CDBG areas throughout the City of Pittsburgh, at a cost not to exceed One Million Four Hundred Thousand (\$1,400,000) Dollars,
