**Be it resolved by the Council of the City of Pittsburgh as follows:**

Resolution amending Resolution 279 of 2022, The Mayor and the Director of the Department of Innovation & Performance, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Professional Service Agreement(s) and/or Contract(s) with Planet Technologies in a form approved by the City Solicitor in order to provide for compensation in the amount FourHundred Fifty-Seven Thousand Two Hundred Eighty Dollars and Zero Cents (\$ 457,280.00) is hereby amended as follows:

**Section 1.** The Mayor and the Director of the Department of Innovation & Performance, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Professional Service Agreement(s) and/or Contract(s)

**and/or Amendment(s)** with Planet Technologies in order to provide for compensation ~~in the amount Four Hundred Fifty Seven Thousand Two Hundred Eighty Dollars and Zero Cents (\$ 457,280.00)~~ by **increasing the cost by One Hundred Five Thousand Dollars (\$105,000) at a total cost not to exceed Five Hundred Sixty Two Thousand Two Hundred Eighty Dollars (\$562,280).**

**Section 2.B.** The City Controller shall encumber funds for the annual contract, subject to the amount of funds to be appropriated by City Council in respective budget years, as follows:
