WHEREAS, Mrs. Murchison also demonstrated faithfulness in public service through employment with the federal government for 11 years and served as Secretary of a District of Columbia American Legion Women's Auxiliary; and,

WHEREAS, Mrs. Murchison provided, with her husband of 63 years, Willie J. Murchison, highly regarded participation, encouragement and support to the Central Northside and Mexican War Streets neighborhood councils; and,
