Resolution amending Resolution 875 of 2019 providing for an Agreement(s) and Contract(s) with Openbox Design, LLC E. Holdings, Inc to assist the City plan and develop a Community Visioning Study with the Department of City Planning and the East Hills and Lincoln Lemington-Belmar communities and provide for the payment at a cost thereof, not to exceed \$200,000.00.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of City Planning are hereby authorized to enter into contract with Openbox Design, LLC E. Holdings, Inc to develop a master plan for the Community Visioning Study. The study should be executed for a sum not to exceed Two Hundred Thousand Dollars (\$200,000.00) Ninety Thousand Two Hundred Eighty-nine Dollars and Seventy-six Cents (\$90,289.76). This cost includes community outreach, inventory/analysis, plan alternatives, and final vision plan.

**Section 2.** Monies used for the Agreement with a consultant in furtherance of the Community Visioning Study will be chargeable to and payable from the following accounts:
