Resolution amending Resolution No. 389, effective June 23, 2005, entitled "Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to submit an Application to the Pennsylvania Office of the Budget for a Redevelopment Assistance Capital Program grant in the amount of \$5,000,000 for the Junction Hollow Phase II project" by increasing the grant to \$9,000,000. (Council District 8)

Whereas, by Resolution No. 389, effective June 23, 2005, the Council of the City of Pittsburgh authorized Urban Redevelopment Authority of Pittsburgh ("URA") to submit an application to the Commonwealth of Pennsylvania Office of the Budget (the "Commonwealth") for a grant under the Redevelopment Assistance Capital Program ("RACP") in the amount of \$5,000,000 for the Junction Hollow Phase II project (the "Project"); and

Whereas, the Commonwealth has increased the grant to \$9,000,000, which requires an amendment to Resolution No. 389 to reflect the increased grant;

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution No. 389, effective June 23, 2005, which currently reads as follows:
