Resolution adopting Plan Revision to the City of Pittsburgh's Official Sewage Facilities Plan for East End Cooperative Ministry Community Building located at 6140 Penn Circle North, Pittsburgh, Pennsylvania 15206.

WHEREAS, East End Cooperative Ministry has proposed the development of a certain parcel of land identified as East End Cooperative Ministry New Community Building located at 6140 Penn Circle North, Pittsburgh, PA 15206, Allegheny County, in the 11th Ward of the City of Pittsburgh and described in the attached Sewage Facilities Planning Module (the "Planning Module") for land development and proposes that project be served by a sewer tap-in to the City of Pittsburgh sewage systems; and

WHEREAS, the Pittsburgh Water Sewer Authority, the Allegheny County Sanitary Authority, the City of Pittsburgh Planning Department and the Allegheny County Health Department have reviewed the respective components of the attached Planning Module in regard to each authority/department's expertise and have approved the respective components as explained in the attached Planning Module.

WHEREAS, based upon the approval of the above authorities and departments, the City of Pittsburgh finds that the project described in the attached Planning Module for land development conforms to applicable zoning,

subdivision, other municipal ordinances and plans, and to a comprehensive program of pollution control and water quality management.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PITTSBURGH AS FOLLOWS:

SECTION 1. The City of Pittsburgh hereby adopts and submits to the Department of Environmental Protection for its approval as a Plan Revision to the City of Pittsburgh's Official Sewage Facilities Plan, the above-referenced Planning Module for land development, which is attached hereto as **Exhibit A.**

Said Planning Module includes the proposed East End Cooperative Ministry New Community Building located at 6140 Penn Circle North, Pittsburgh, PA 15206, Allegheny County, in the 11th Ward of the City of Pittsburgh.
