Resolution providing for an Agreement or Agreements, or use of existing Agreements and/or a Contract or Contracts, or use of existing Contracts for the purchase of communications equipment for the Bureau of Fire and providing for the payment of the costs thereof, at a cost not to exceed Forty One Thousand Nine Hundred Eighty Two Dollars (\$41,982.00).

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and/or the Director of the Department of Public Safety or Director of the Department of General Services, on behalf of the City of Pittsburgh, are hereby authorized to advertise for proposals and to award and enter into an Agreement or Agreements, or use existing Agreements and/or Contract or Contracts, or use existing Contracts for the purchase of communications equipment and related accessories for the Bureau of Fire at a cost not to exceed Forty One Thousand Nine Hundred Eighty Two Dollars (\$41,982.00) chargeable to and payable from Account 542700, Fund 5100, Organization 250000, Sub-Class PGHPR, Project/Grant 2263001, Budget Year 2001, Department of Public Safety.
