NOW THEREFORE, BE IT RESOLVED that the Council of the City of Pittsburgh calls upon Governor Ed Rendell and the Pennsylvania state legislature to retain the original budget proposal of \$14 million in grants through the Pennsylvania Council on the Arts and the Pennsylvania Historical and Museum Commission; and **BE IT FURTHER RESOLVED** that a copy of this resolution shall be transmitted to the Mayor of Pittsburgh, to all members of the Pennsylvania General Assembly, and to the Governor of Pennsylvania.
